The Obstacle Problem for Quasilinear Stochastic PDEs

Abstract: Using analytical methods, we prove existence and uniqueness of the solution of quasilinear stochastic PDEs with obstacle. The solution is expressed as pair (u, μ) where u is a predictable continuous process which takes values in a proper Sobolev space and μ is a random regular measure satisfying minimal Skohorod condition.
